**Committee Responsibility:** The main responsibility of the Memorial Services Committee is to make all arrangements and plans for the "IVY BEYOND THE WALL" Service for deceased Sorors and to maintain all necessary supplies for this ritual. Two sets of these supplies are currently maintained; one in the Ruth Coleman Room at the Service Center and one set at the home of the Committee Chairman, Myrtle Burton-Sahara. All requests for the Service must be made directly to the Basileus.

Upcoming Activities – The committee cannot predict the number of Ivy Ceremonies that will be requested but, where possible, try to maintain the materials required. It should be noted that Ivy Ceremonies can be requested for all deceased Sorors, active or inactive. Occasionaly, these ceremonies are requested for members from other chapters. Sometimes, these requests come from our Corporate Office. Ten ceremonies were conducted by Theta Omega Chapter during 2015. One Ceremony was conducted for IBTW Soror Marva J. Lee on January 23, 2016. The number of sorors who actively participate in a ceremony impacts the expenses incurred for any given ceremony. During 2015, the number of Sorors participating in the ceremonies ranged from 14 to

In the past, silk ivy leaves were used for the ceremonies and retained for use in the forthcoming ceremonies. Copies of the full ceremony were only issued to the Basileus (Leader) and the four Readers who participated in the Ceremony. Other Soror participants were only issued the (half-page) song sheets for use during the Ceremony.

Financial Report - For many years, the yearly allocation for the Memorial Services Committee has been \$250.00. This was to cover the cost of all materials, paper supplies and other items such as table cloth, candles, printing, etc. A live ivy plant is always purchased and presented to the family of the deceased.
